**TEMPORARY CLOSURE OF 41104 GREEN STREET
(BROCKWORTH PARISH) TEWKESBURY BOROUGH**

Gloucestershire County Council has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of the 41104 Green Street from its junction with Greenway to its junction with Ermin Street for a distance of approximately 88 metres.

The reason for the closure is for a new water connection.

The road is expected to be closed from 24th April 2019 until 26th April 2019 only or until the works have been completed. For further information, please contact Gloucestershire Highways on **08000 514 514** or visit **www.gloucestershire.gov.uk**.

Alternative Route – As signed on site.

Pedestrian access to premises on or next to the road and Emergency access will be maintained.

TEMPORARY TRAFFIC ORDER
41104 GREEN STREET (BROCKWORTH PARISH)
(TEWKESBURY BOROUGH) ORDER 2019

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for 41104 Green Street from its junction with Greenway to its junction with Ermin Street for a distance of approximately 88 metres ("the Road") is satisfied that use of the Road should be prohibited because works are being or are proposed to be executed on or near it.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Road;
2. Nothing in Article 1 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Road;
3. Nothing in Article 1 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Road;
4. The Road falls in Brockworth Parish in the Tewkesbury Borough and in the County of Gloucestershire;
5. This Order shall come into operation on the 24th day of April Two Thousand and Nineteen and shall continue in force for a period not exceeding eighteen months;
6. This Order may be cited as "Gloucestershire County Council Temporary Traffic Order 41104 Green Street (Brockworth Parish) (Tewkesbury Borough) Order 2019".
7. In the event of any inconsistency or ambiguity between the content of this Temporary Order and any existing permanent/experimental Order(s) imposing restriction(s) on the Road or diversion routes the latter will be suspended for the duration of the works and the provisions of this Temporary Order shall prevail during that period.
